1. \$15.00 Registration Fee (\$18.75 Out-of-District) NO REFUNDS on Registration Fee.
2. \$80.00 per session per camper. (\$96.00 Out-of-District)
3. To place deposits, you MUST pay in full for the first session of camp your child will be attending and then a \$10.00 deposit on each additional session. This deposit is deducted from your balance (example: After paying in full for the first session of camp your child is attending, the second session is \$80. You must put a \$10 deposit down to hold their spot when registering. You will owe \$70 when this session is due.

5. Out-of-District fee applies to residents living in the city limits of Greenville, Greer, Simpsonville and Mauldin, or those living outside of Greenville County.
6. Session must be paid in full before child may attend the next session.
