Fast Facts: \$380 per team weeknight leagues. \$310 per team Sunday league. Registration runs May 31st – September 6th. Entry fee covers a 8-game season (6-game season for 11v11), pre-season practices, post-season playoffs, facility rental, field supervision, and post-season awards.

Official Fees are \$15 per 7v7 game and \$80 per 11v11 game, paid to the official on the field prior to game time.

Coed 7v7: Sundays @ Pavilion or Mondays @ Pavilion
 Men's 7v7: Sundays @ Pavilion or Thursdays @ Pavilion
 Men's 11v11: Tuesdays @ Northwest Park
 Men's 40 & over: Wednesdays @ Pavilion

There will be one Monday Coed 7v7 and one Thursday Men's 7v7 Free Agent Team for individual players. Cost \$45, includes jersey.

- Individuals must be at least 18 years of age by September 12, 2022 to participate.
- Individuals looking for a team can register for one or both of the House 7v7 teams, or place their name on the Free Agent list for Coed 7v7, Men's 7v7, 40 & older, & Men's 11v11. To be added to the soccer free agent list, email rdixon@greenvillecounty.org.
- Individuals can only play on one team in each division. Team captains must notify Greenville County Rec before the start of the season if an individual is playing on more than one team.
- Teams may not change their name after registration. Please keep team names in good taste.
- Special requests for game days, times, fields, or schedule changes will not be honored.
- Fees must be paid before you can play in the league and receive practice time.
- Teams are required to wear shirts/jerseys of the same color, with different numbers. Each player must have a visible number on his/her jersey.
- A \$15.00 administrative fee will be charged for teams dropping out on or before Tuesday, September 6th 2022. No refunds are available to teams dropping out after Tuesday, September 6th, 2022.
- Registered teams may schedule one (1) free practice each week before the season starts. Once the season starts, teams may continue to schedule practices but standard Greenville County Rec facility rental rates will apply, and availability is often limited. Please contact Rich Dixon at rdixon@greenvillecounty.org to book a practice time.
- During the registration process, team captains will complete a payment authorization form. In the instance of a forfeit, Greenville County Rec will automatically charge the credit/debit card on file \$30.00 for 7v7 and \$180.00 for 11v11 the next business day following the forfeit.
