Application and appropriate Fees A completed race event application form and \$50 non-refundable fee are due to Greenville County Rec at least 90 days prior to the requested event date. All applicable fees are shown below:

Certificate of Liability Insurance Policy with at least \$1,000,000 of coverage per event. Greenville County must be listed as additional insured as follows: County of Greenville, 301 University Ridge, Greenville, SC 29601, 864-467-7100. If you will have inflatables, please also provide a certificate of insurance from the rental company using the same specifications as above.

Course Map and Event Layout A course map with start and finish locations clearly labeled is due with the application, with the exception of races at Conestee Park (Greenville County Rec will provide a 5K course map). All events, including at Conestee, require submission of an event layout diagram, including the location of tents, vendors, inflatables, food trucks, portable restrooms, and any other event equipment.

City of Greenville Special Event Permit A City of Greenville event permit is required for all races in Conestee Park. A City of Greenville event permit is required for all races on the GHS Swamp Rabbit Trail that fall partially in the Greenville City limits, and partially in Greenville County. Follow the instructions at www.greenvillesc.gov to submit your Special Event Application: www.greenvillesc.gov/DocumentCenter/View/10281. The City of Greenville has its own fees and certificate of insurance requirements, in addition to the ones indicated above. **Please submit a copy of your approved City of Greenville permit to Greenville County Rec.**

City of Travelers Rest Special Event Permit If your event is taking place at Gateway Park, Trailblazer Park, and/or the GHS Swamp Rabbit Trail, and all or part of the course lies in the city limits of Travelers Rest, a City of Travelers Rest event permit is required: <http://travelersrestsc.com/wp-content/uploads/2018/06/Special-Event-Permit-Application.pdf>. The City of Travelers Rest may require their Police Department to assist with traffic control along the race course and/or parking. **Please submit a copy of your approved City of Travelers Rest permit to Greenville County Rec.**

Timing and Registration Website: Please provide links to your registration website and timing company.

The applicant is responsible for providing timing, volunteers, race registration, marketing, prizes, awards, medical support, and additional restroom facilities. Vendors must abide by local governing laws and codes. Alcohol is NOT permitted at any Greenville County Rec park or facility, including the GHS Swamp Rabbit Trail.
