



Scholarship Application Guidelines For Parents/ Guardians Summer Camp 2026

PLEASE READ ALL THE INFORMATION BELOW BEFORE APPLYING. All prospective participants with financial needs are eligible to apply for assistance. Greenville County Rec cannot guarantee that every request will be honored. Scholarships are based on the financial need of the family and there are a limited number available.

Scholarship Guidelines

1. Scholarships are awarded on a first complete, first served basis.
2. Scholarships are available for the program fee only. **Other expenses the participant may incur are not covered by scholarships.** Scholarships cover 50% of the program fee.
 - At the time of registration, a \$100 payment **per child** is due (\$50 towards program fee and \$50 non-refundable registration fee). With scholarship applied, there will be a remaining balance of \$127.00 per child (elementary camp) and \$137.00 per child (teen camp) due on or before Friday, May 1, 2026.
 - Remaining balance will be due by Friday, May 1, 2026. No refunds after Friday, May 1, 2026.
3. You must meet **both** of the following scholarship qualifications in order to apply for assistance:
 - The participant and parent and/or legal guardian **must be** residents of Greenville County (proof of residency may be required).
 - Documentation of financial need is required through **one of the following**:
 - I. Free/reduced lunch award letter for current school year listing the participant's name (this will not be considered valid documentation if the entire school qualifies for free or reduced lunch).
 - II. Current Medicaid documents for the child(ren) in the household (not cards).
 - III. Current TANF/EBT documents for the primary guardian or child (not cards).
4. The scholarship application must be completed in full and appropriate documentation must be included. A complete application submission includes: one scholarship application, supporting documentation which list each child, program registration form for each child, program waiver for each child and auto draft form (if applicable). Providing false or incomplete information on the application will result in disqualification. **Incomplete submissions will not be considered.**
5. Scholarship applications **must** be submitted **in person** to the Center Managers (see below).
6. If your request is granted, you will be notified by the Manager as to the scholarship amount and remaining balance. Upon receiving this notification, you will be expected to make your initial payment **within two weeks of the notification or risks losing the scholarship.**
7. If you fail to make your payments on time or if you leave the program, your scholarship will be revoked.
